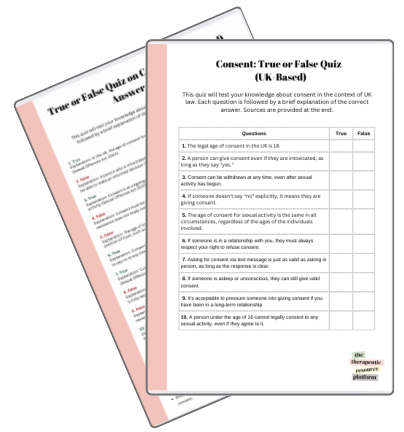

##### True or False Activity

Our True or False activity is an engaging way for you to share knowledge with participants. It can be done in a one-to-one setting or within a group. Simply print the worksheet, distribute it, and have participants answer the questions. Once they're finished or after 15 minutes, go through the answers together and discuss them in more detail.

Alternatively, you can ask the questions verbally and have participants show True or False flashcards in response. Flashcard templates are available on our website.

##### Consent, true or false activity:

This True or False activity educates participants about sexual consent, empowering them to make informed choices and act responsibly.

#### Materials Needed

#### Step by Step Instructions

1. Print out the true or false quiz sheet **OR** print out our flash cards if you plan on asking the questions verbally.
2. Give participants time to answer the questions. Then go though each questions and their answers.

# Consent: True or False Quiz (UK-Based)

This quiz will test your knowledge about consent in the context of UK law. Each question is followed by a brief explanation of the correct answer. Sources are provided at the end.

Questions	True	False
1. The legal age of consent in the UK is 16		
2. A person can give consent even if they are intoxicated, as long as they say "yes."		
3. Consent can be withdrawn at any time, even after sexual activity has begun.		
4. If someone doesn't say "no" explicitly, it means they are giving consent.		
5. The age of consent for sexual activity is the same in all circumstances, regardless of the ages of the individuals involved.		
6. If someone is in a relationship with you, they must always respect your right to refuse consent.		
7. Asking for consent via text message is just as valid as asking in person, as long as the response is clear.

# True or False Quiz on Consent (UK-Based)

## Answer sheet

This quiz will test your knowledge about consent in the context of UK law. Each question is followed by a brief explanation of the correct answer. Sources are provided at the end.

### 1. True

Explanation: In the UK, the age of consent for sexual activity is 16, regardless of gender or sexual orientation (Sexual Offences Act 2003).

### 2. False

Explanation: A person who is intoxicated (through alcohol or drugs) cannot give valid consent, as they may not be able to make an informed decision (Sexual Offences Act 2003).
